Some key challenges for North Shore will be continued focus on improving reading, science, writing, math, and building climate. To address the latter areas, parental involvement strategies, curriculum adoptions and updates, setting learning targets for students (student ownership), positive behavior supports to address behavior needs, as well as utilizing a multi-tiered system of support (RtI framework) either have been implemented or will be implemented in the future.

1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL

All district and schools of choice students who are enrolled at South Haven Public Schools for 4th and 5th grades are assigned to North Shore Elementary School. It is the only school in the district that houses and serves these grades. We receive students from both primary elementary buildings, Lincoln Elementary and Maple Grove Elementary, after students complete the 3rd grade.

2. THE STATUS OF THE 3-5 YEAR SCHOOL IMPROVEMENT PLAN North Shore has been updating the school improvement plan for the 2016-2017 school year. We have been diligently working on curriculum alignment to the Common Core State Standards. After the 1st administration of the M-Step Assessment and the resulting low proficiency scores, it is clear that the district is lacking a comprehensive K-5 curriculum in ELA and mathematics. Our school

improvement plan will be overhauled to include ELA pilots and subsequent purchases, as well as math curriculum pilots.

THE AGGREGATE STUDENT ACHIEVEMENT RESULTS FOR ANY LOCAL COMPETENCY TESTS OR NATIONALLY NORMED ACHIEVEMENT TESTS North Shore Elementary participates in benchmark assessments using the NWEA MAP Test. The following chart displays the percentage of students who scored at or above the norm grade level mean RIT in reading and mathematics in the spring of 2014 and 2015:

6. IDENTIFY THE NUMBER AND PERCENT OF STUDENTS REPRESENTED BY PARENTS AT PARENT-TEACHER CONFERENCES

Attendance rates for parent-teacher conferences has been relatively high at the elementary level. For the past 5 years, there has been a 93-94% attendance rate for parents at conferences. If we include phone conferences and meetings after the scheduled conference dates, the attendance rates would increase to approximately 97-98% each year.

North Shore Elementary is a great school. It's a place where students are the highest priority. Our staff is committed to excellence and works tirelessly to provide a rigorous curriculum and learning opportunities and experiences that promote student success.
